We honor the legacy of the Black American Sailors of Port Chicago by engaging youth, informing communities, and advocating for restitution—ensuring their courage, sacrifice, and contributions to civil rights and World War II are never forgotten.
- **Vision Statement:** We envision a nation where the Port Chicago Sailors are fully recognized as American heroes, their families receive long-overdue justice, and their story becomes an essential part of American education, civic pride, and cultural memory. Through remembrance, advocacy, and community empowerment, we strive to inspire future generations to stand for fairness, service, accountability, and self-pride.

# • What was the Port Chicago disaster?

The Port Chicago disaster was a massive explosion on July 17, 1944, at the Port Chicago Naval Magazine in California. Munitions being loaded onto a ship detonated, killing 320 Sailors and civilians and injuring 390 others. Most of the Sailors killed were young Black enlisted men working under hazardous and segregated

conditions. It was the deadliest home front disaster of World War II.

## • Why is it historically significant?

The disaster exposed the U.S. Navy's racially segregated labor practices, unnecessarily hazardous working conditions, and lack of proper training. After the explosion, 50 Black Sailors refused to resume loading ammunition under the same hazardous and discriminatory conditions. Their protest and subsequent trial became a catalyst for national conversation about civil rights, military segregation, and justice—ultimately helping prompt the desegregation of the U.S. Navy in 1946.

## • Why were the Sailors convicted?

Following the disaster, 50 Sailors refused to continue loading ammunition due to unsafe conditions. The Navy charged them with mutiny—the most serious military offense—without recognizing their protest as a legitimate request for safe working conditions. Denied due process in a racially biased trial, all 50 were convicted and sentenced to prison despite having no intent to overthrow command.

#### • What does exoneration mean today?

Exoneration means formally clearing the Port Chicago Sailors of their wrongful convictions. In July 2024, the U.S. Navy officially exonerated 256 Port Chicago Sailors, acknowledging that they were unjustly tried and that racism and unsafe practices contributed to their actions. Exoneration restores their honor,

corrects the historical record, and paves the way for restitution for their families.

#### • What is PCA's role in this history?

The Port Chicago Alliance (PCA) preserves the history of the Port Chicago Sailors, advocates for justice, and supports their descendants. PCA leads public education and youth programs, oversees historical preservation, and advances legislative initiatives like Port Chicago Remembrance Day. Our members have successfully advocated to name Thurgood Marshall Regional Park: Home of the Port Chicago 50, pushed for resolutions supporting exoneration, and organized letters and calls to the Navy urging official exoneration. Through these efforts, PCA ensures the Sailors' legacy is honored, remembered, and passed on to future generations.
